Fundingforpostgraduate teacher training

Students on postgraduate teacher training programmes such as PGCE, either at a university or School Centred Initial Teacher Training (SCITT), or on the non-salaried Schools Direct programme will be liable for tuition fees but may be eligible for a bursary. Further details below:

Your tuition fees and any other bursary or financial support depend on your status as a home or overseas student. All grants and bursaries are subject to conditions, and you are not guaranteed funding, but you may be eligible for financial support.

Tuition Fee and Maintenance loans

If you are on a postgraduate Initial Teacher Training course (ITT), you will have to pay tuition fees. These may vary depending on the course and provider.

Tuition fee and maintenance loans for Home and pre-2021 entry, settled or pre-settled status EU students are available from Student Finance England so that you don't have to find the fees up front.

If eligible, you can apply for a Tuition fee loan and a Maintenance loan

Training Bursaries and Scholarships

These are tax-free amounts of money you receive to train in certain subjects. You do not need to pay them back if you complete your course. To receive a bursary or scholarship you must be eligible for Student Finance support (unless you are training to teach physics or languages). Both elements will be assessed by your teacher training provider.

You do not need to apply for a bursary. If you're eligible, you'll automatically receive it. To be eligible for a bursary, you'll need at least one of the following:

- a bachelor's degree class 2:2 (honours) or higher
- a master's degree
- a PhD

To be eligible for a scholarship, you'll need at least one of the following:

- a bachelor's degree class 2:1 (honours) or higher
- a master's degree
- a PhD



In exceptional circumstances, if you achieved a 2:2 in your degree you may still be awarded a scholarship if you have significant relevant experience.

Non-UK trainees should read <u>Train to teach in England as a non-UK citizen</u>. Applicants with a degree from outside the UK should use <u>Teach in England if you trained outside the UK.</u>

School Direct Salaried Scheme

A number of schools offer School Direct salaried schemes. To be eligible for this teacher training route, applicants must have at least 3 year's transferable work experience. Trainees are recruited and employed directly by schools and may continue teaching in the school following training. The training via a salaried route will award QTS, and the cost of this is covered by the school. Students will be paid and taxed as an unqualified teacher. Salaries will vary depending on the school.

Postgraduate Teaching Apprenticeship

This programme offers a combination of classroom teaching, practical learning, and a salary. Students receive a combination of classroom teaching and 20% of the time is allocated to off-the-job training as students work towards qualified teacher status (QTS). Students are expected to undertake an end-point assessment (EPA) in the final term to ensure they are on-track to become an effective teacher.
